



### MINUTES OF NATIONAL JURAL MEETING

The members of the National Jural Society of ARNA-IPA held a Prosecuting meeting on Sunday, 17<sup>th</sup> of April 2022/day 27 month 1 of the year 15,108 on the Aboriginal Calendar (Chief Jurist private location via Zoom). The meeting began at CST. 3:30PM and ended at 5:30PM.

- 3. ACTIONS TAKEN. The members took the following actions:
  - [X] The invitation of the NJS members' meeting held on Sunday, 17<sup>th</sup> of April 2022/ day 27 month 1 year 15,108 on the Aboriginal Calendar was accepted by all appointed jurists and approved by the **Chief Jurist**.
  - [X] THE MEMBERS TOOK THE FOLLOWING ACTIONS:

Kojo Xi Shabazz withdrew his vote on the case, due to a conflict of interest. Arkan Shabazz's vote was recused but retained the remainder of his rights as a member of the National Jural Society, decided by a majority decision on the matter. Ansâr El-Muhammad, Marvin Bey, Trazell Onojo, B'aK Amaru and Rashad El-Bakari Muneer wholeheartedly and voluntarily voted and elected that Nu Ways Legal and K'in Way Xi are GUILTY of counts 1, 3, 4, 5, 6, 7, and 9, Crimes and or Violations against Love Xi, Yasmin Xi-Ali, Karen Baber and ARNA Headquarters.

[X] CNJ, Ansâr El-Muhammad voted and elected an Undecided decision finding Nu Ways Legal and K'in Way Xi Guilty or Not Guilty of count 8 from the NOTICE of PROSECUTION of DEFENDANTS CRIMES against Headqurters on Sunday, 17th of April 15,108 [2022].
